A couple may contribute \$78,400 for the general 2026 election from a joint account if both parties' names are printed on the check and both parties sign the check. Contributions must be made by the donor's own funds and may not be reimbursed by any other person. Contributors must be at least 18 years of age. Contributions from foreign nationals are prohibited.
